Results











Feedback of participants (126 respondents, 15% of enrolled)




Positive impact of materials: 97% agrees

How strongly do you agree or disagree with the following statement: The course materials (lectures, videos, documents) have had a positive impact on my learning experience.




Positive impact of activities: 93% agrees

How strongly do you agree or disagree with the following statement: The course activities (discussions, quizzes) have had a positive impact on my learning experience.




Overall rating: 93% gives 4 - 5

Comments received in the participant experience survey demonstrate a high level of appreciation of the course and describe it as very relevant for professionals dealing with children. Materials and discussions were marked as challenging by some respondents, who nevertheless confirm the value of the course; on the other hand, some participants recommend adding more assessment and even assignments, and engaging in the discussion in a deeper/more critical manner: such diverse feedback show the heterogeneity MOOC audiences. Some participants show an interest in acquiring credits, and avenue that the Global Campus has already considered but so far never managed to implement because of procedural/bureaucratic difficulties. A few wish the course was also available in other languages (especially Spanish and French).

Remarkably, the course has managed to strike a balance between offering basic knowledge to participants who were new to the topic, as well as valuable insights to professionals already working with children or youth.
