






# A deep-dive into our audience

It has been truly fascinating to learn about new or not-yet-fully-analysed audiences enrolled in this MOOC. In our surveys we certainly saw the 'usual' profiles: current or prospective students and researchers in human rights (or in other areas where a human rights approach is seen as an added value); educators; professionals who are seeking to make a shift in their careers or looking for/applying to a job; legal experts; officers of the UN, EU and other international institutions; NGO practitioners, activists/defenders and human rights campaigners; journalists and bloggers; volunteers; trainees.


On top of these, this course has genuinely interested also professionals from other areas: conservationists and environmental experts; specialists working with multinational corporations on the SDGs (including members of the <u>2021 Luxembourg initiative</u>); engineers and entrepreneurs in mining, water, farming, oil and apparel companies; business strategists and experts dealing with supply and value chain, social and environmental sustainability, and multi-stakeholder dialogue settings; corporate advisors and business analysts; policy makers; young entrepreneur planning their business; procurement experts; legal professionals working in litigation, criminal, corporate and climate law; proposal writers; marketing researchers; even a Nigerian producer of an advocacy serial drama for their national television (in collaboration with National Human Rights Commission of Nigeria) which aims to fight against the caste system.

Our participants bring their own cross-sectionality (migration, work in conflict zones, health, gender, diversity, children, human trafficking, refugees) and are actives in countries such as Albania, Nigeria, Argentina, Honduras, Brazil, Peru, China and Palestine where they work on specific projects around human rights in the private sector.




## Positive impact of materials: 97% agrees

How strongly do you agree or disagree with the following statement: The course materials (lectures, videos, documents) have had a positive impact on my learning experience.




# Overall rating: 93% gives 4 - 5 ★

Please give this course an overall rating on a scale of 1 to 5 with 1 being the lowest and 5 being the highest rating




### Positive impact of activities: 92 % agrees

# **Beyond lifelong learning: enabling change**

This MOOC hit a niche area that sparks a lot of interest (over 2271 people enrolled, 16% of which obtained the certificate) and where opportunities for creating impact are huge. Participants states their eagerness to put the course' knowledge at work: not only NGOS, international organisations, officers of national institutions working on policy and national

action plans, experts dealing with evaluations of development cooperation projects; but also, representatives of companies and multinational corporations valued the tools they gained to build capacity and catalyse action for change in their sector (*"my organization is developing its own Human Rights Due Diligence process and building up new services for businesses going beyond certification and auditing*). They intend to prevent and redress human rights violations by working with their leadership, members, suppliers, clients and community stakeholders.

Participants' comments also reveal that, despite the very intensive nature of this MOOC, they not only were eager to study in depth, but also to share their questions and experiences with the MOOC community. Moreover, many stated that they will hand the courseware to their staff/colleagues to build capacity in their work environment, and hope more free courses and even degrees could be offered in this topic.

The success in terms of enrolment was also made possible by the considerable support we received from our lecturers, who joined the Global Campus in spreading the word via their own network. Working in advance with our speakers, and specifically in terms of promotion, definitely pays off; this is an approach we will keep on employing in all our future MOOCs.

# More than a MOOC

Participants' feedback shows that Global Campus MOOCs are perceived as "non-standard MOOCs": the quantity and quality of the global interaction, willingness to share with peers, academic support, and tutors' encouragement go way beyond what open massive education usually offers. Such a result cannot be achieved without sustained work and dedication from the Global Campus staff; we are looking forward to keep these expectations high in our forthcoming MOOCs.

## **POTENTIAL FOR CHANGE**

I deal with serious human rights violations on a daily basis, most of them as a result of exploitation of resources. I want to reconcile the business aspect with the respect of human rights and how to promote accountability.

My work is about promoting accountability of international financial institutions; thanks to this course I am more aware of the risks that these institutions private financing arms might pose.
